#### 1. CALL TO ORDER

Mr. Michael DeBlasio, Board President, called the meeting to order at 6:03 p.m.

### 8. CCSP SENIOR LEADERSHIP (CEO and DCI)

Dr. Makeba McCray provided a presentation on NWEA assessments for Math, ELA and Science, including student participation, student growth, grade level comparison, and predictions for NJSLA assessment. The Board asked Dr. McCray to provide general observations and recommendations about student academic performance based on the results of the NWEA. Dr. McCray stated that a key factor for improving student academic performance is the hiring of strong teachers. Dr. Palmore added that quality execution of the summer program will also be key to improving student performance in the 2022-2023 schoolyear. Dr. Steve Sandor, Humanities Supervisor, provided a presentation on F&P assessments. Dr. Sandor recommended adding guided reading, targeting comprehension, intervention for students for reading below level, and training, monitoring and support for teachers in implementing intervention plans for students.
