# MINUTES FROM THE REGULAR MEETING OF THE BOARD OF TRUSTEES SEPTEMBER 24, 2020

The Board of Trustees of the Community Charter School of Paterson (the "School") held a Regular Meeting of the Board of Trustees on Thursday, September 24, 2020, via the Zoom platform due to the public health emergency. The public was able to participate in the meeting by dialing 1-929-205-6099.

#### 1. CALL TO ORDER

Board President Mr. Michael DeBlasio called the meeting to order at 6:09 p.m.

#### 2. SALUTE TO THE FLAG

#### 5. COMMENTS FROM THE PUBLIC

Keisha Smith, CCSP Operations Manager, thanked the administrators and staff for their continued hard work and dedication to the Community Charter School of Paterson. Ms. Smith remarked that she has been working at CCSP for 6 years and continues to appreciate everyone's efforts to serve the children and families of CCSP.

#### 7. BOARD PRESIDENT'S REPORT

#### 8. CCSP Senior Leadership (CEO, DCI, Principals, Director of Community Schools)

Mr. Curtis Palmore commenced the senior leadership presentations. Mr. Palmore thanked teachers, administrators, board members, support staff, and parents for their effort to prepare, and engage children through online learning.

Mr. Palmore led the Board and meeting participants in a moment to honor the lives of the late Ruth Bader Ginsburg, and the late Breonna Taylor.

Mr. Palmore provided an update on student enrollment and current waiting list. Mr. Palmore advised that more than 500 families participated in the Virtual Back to School Night. Mr. Palmore advised that staff and families expressed excitement and enthusiasm about back to school night. Mr. Palmore provided an update on the preparations for returning to in-person learning.

Ms. Charlotte Hausen provided an update on virtual learning for the Elementary School campus. Ms. Hausen shared different strategies being used by teachers to keep children engaged in online learning. Ms. Hausen advised that as a part of ELA teachers have created an online digital library for students.

Mr. Michael Bussacco provided an update on virtual learning for the Middle School campus. Mr. Bussacco advised that teachers have created teacher websites that include resources, calendar, and lessons for students to access online. Mr. Bussacco indicated that the Virtual Back to School Night was a success, and families that were not available to attend at the original time were able to playback a recording of the event. Mr. Bussacco discussed morning meetings, SEL Class, Social Studies, teacher planning, and upcoming virtual engagement and fundraising events.

Dr. Lisa Schneider provided an update on curriculum and instruction. Dr. Schneider stated that CCSP is working on partnering with William Paterson University in order to connect WPU's Teacher Training program with CCSP students. Dr. Schneider described the teacher evaluation tool proposed for use this school year. Dr. Schneider and the Board discussed elements of the proposed teacher evaluation tool. Dr. Schneider provided an update on the launch of intervention programs.

Ms. Dacil Tilos presented the 2020 Community Schools Annual Board Presentation. Ms. Tilos highlighted that attendance during the 2020 summer program was lower than originally estimated due to the coronavirus pandemic. Ms. Tilos presented a plan for Community Schools for 20-21. Ms. Tilos advised that Before Care will begin October 5. Expanded Learning Time will begin virtually on October 5, with a plan to be on-site on November 2. Mr. Guarasci asked if 21<sup>st</sup> Century will accept virtual classes towards level of service. Ms. Tilos responded that 21<sup>st</sup> Century does accept attendance in virtual programming towards level of service. Ms. Tilos presented the proposed schedule for 20-21 Expanded Learning Time. Ms. Tilos advised that Community Schools

has created a Google website. Ms. Tilos provided a list of upcoming events and meetings for Community Schools.
