12. CCSP SENIOR LEADERSHIP (CEO, DCI, Principals, Director of Community Schools)

Dr. Curtis Palmore provided on update student enrollment. Dr. Palmore illustrated that a total of 901 students are currently seated. Dr. Palmore provided an update on teacher hires. Dr. Palmore expressed that three teacher vacancies remain unfilled at the elementary campus and ten teacher vacancies at the middle school campus. Dr. Palmore advised that CCSP will host an open house event and continue mass media advertising to fill vacant teacher positions. Dr. Palmore and Board Members discussed contingency plans for vacant teacher positions that are not filled at the start of the school year. Dr. Palmore provided an update on planning for teacher pre-service.

Ms. Paneto-Gonzalez provided a summary of her efforts and goals for July and August for the elementary school including building relationships with staff and faculty, identifying students and families challenged by chronic absenteeism, physical building preparedness, filling teacher vacancies, and pre-service preparations.

Mr. Sean Sawyer provided an update for the middle school including his yearend takeaways for the 2021-2022 school year, yearend highlights, pre-service planning, summer focus items and goals for the 2022-2023 school year. Mr. Sawyer expressed that goals for the 2022-2023 school year include filling teacher vacancies, using data to improve student performance, planning engaging professional development, implementing student WINN periods as real time academic intervention (Whatever I Need Now), and scheduling clean slate meetings with families.

Ms. Sarai Lucero provided an update on the Community Schools Summer Program. Ms. Lucero advised that CCSP met its required level of service for the 21st Century program year. Ms. Lucero discussed summer program academic and club activities, summer field trips, and upcoming events.
